When and what might I be concerned about?

At any time you may be concerned about information which suggests a child is being neglected or experiencing physical, emotional or sexual harm.

You may observe physical signs, notice changes in the child's behaviour or presentation, pick up signs of emotional distress or have a child disclose a harmful experience to you.

What should I do if a child discloses that s/he is being harmed?

1. Listen

Listen carefully to what is being said to you, do not interrupt.

2. Reassure

Reassure the pupil that it is not their fault. Stress that it was the right thing to tell.

Be calm, attentive and non-judgemental.

Do not promise to keep what is said a secret.

Ask non-leading questions to clarify if necessary:

Tell me more...
Explain that to me...
Describe what happened....

Then follow the steps in the flowchart to the right.

The information you have may not be enough on its own for a Child Protection referral, however it will help DSL to make a decision about risk of harm to the child.

What must I do?

CPOMS use it.

Otherwise, use "Child Protection - Cause for Concern Form" from the person you inform (using the child's own words), complete it, sign it, date it and pass it back.

What should I do if the alleged abuser is a member of staff?

All concerns of poor practice or possible child abuse by colleagues should be reported to the Headteacher.

Complaints about the Headteacher should be reported to the Chair of Governors.

Whistleblowing helpline - for staff who feel unable to raise concerns about safeguarding practices or issues internally.

Staff may also report their concerns directly to children's social care or the police if they believe direct reporting is necessary to secure action.
